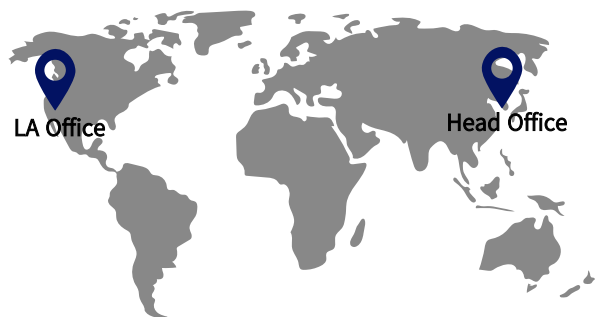

Daeyang is looking for an agent that we can trust and achieve success with over a long period of time.

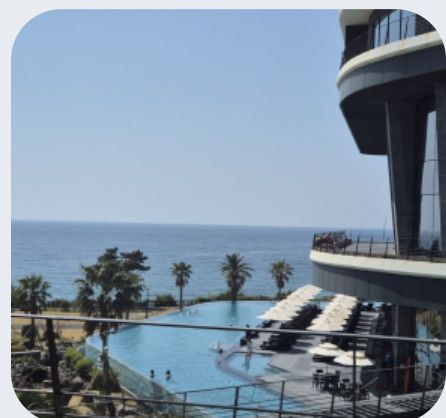
News #2. F-2 Visa (Korean Permanent Residency)

Among the various categories through which foreigners can obtain permanent residency in Korea, there is the F-2 visa.

News #3. President Trump Reveals the Actual \$5 Million Gold Card!



On April 3, 2025, President Donald Trump unveiled the design of a \$5 million gold card to reporters aboard Air Force One. This card, featuring President Trump's face in its unique design, is part of a program aimed at offering U.S. permanent residency to wealthy foreign nationals. So, what is the significance of the gold card announced by President Trump?

The Gold Card – A Potential Replacement for the EB-5 Visa Program?

President Trump has repeatedly mentioned that the gold card is intended to replace the existing U.S. investor immigration program, the EB-5 visa program. Under the EB-5 program, foreign nationals can receive a green card by investing a certain amount of money in the U.S. The gold card, however, is designed as an alternative where foreign nationals can simply pay \$5 million to obtain U.S. permanent residency, without the need for a traditional investment.

If someone obtains a green card through this gold card program, they would be required to file taxes on income earned within the U.S., but would be exempt from taxes on income earned overseas. This benefit is not offered by the existing EB-5 visa program, making it a highly attractive option for foreign investors.

Gold Card Sales and Economic Outlook

Secretary of Commerce under the Trump administration, Howard Lutnick, revealed that more than 1,000 gold cards have already been sold, and over 37 million people worldwide are financially capable of purchasing this card. Furthermore, it was stated that selling 200,000 gold cards could contribute \$1 trillion towards reducing the U.S. national debt, which currently stands at \$36.5 trillion, thereby greatly boosting the U.S. economy.

Expected Launch in Two Weeks, But...

President Trump announced that the gold card would be launched within two weeks. However, in order for this program to fully replace the U.S. investment immigration program, it must first be approved by the U.S. Congress. Therefore, we must continue to monitor how this program will affect U.S. investment immigration and how it will be implemented in practice.

"L Visa – An Essential Tool for Multinational Companies"

The L visa can be an effective tool for multinational companies looking to expand their business into the United States and send key personnel. This non-immigrant visa is designed for transferring employees between a company's headquarters, branches, subsidiaries, or affiliates. It is primarily aimed at senior executives, managers, or employees with specialized knowledge or expertise, enabling businesses to efficiently operate or expand their presence in the U.S.

There are two types of L visas:

L-1A is for senior executives and managers, with an initial stay of 1 year for a new office or up to 3 years for an existing office. It can be extended for up to 7 years.

L-1B is for employees with specialized knowledge, with an initial stay of 3 years and extensions available for up to 5 years. To extend the visa, the employee must demonstrate that they are still using their specialized knowledge and that the U.S. operation of the company is successfully running. "Specialized knowledge" generally refers to skills or processes that are difficult for other companies to replicate.

To apply for an L visa, the applicant must meet basic eligibility requirements. For example, the applicant must have worked for the company for at least 1 year within the past 3 years and prove the relationship between the U.S. headquarters and its branch or subsidiary. The applicant must submit an I-129 petition to the U.S. Citizenship and Immigration Services (USCIS), along with documentation proving the company relationship, the applicant's employment history, job description, and a business plan with financial evidence if establishing a new office. Finally, a visa decision will be made through an interview at the U.S. embassy.

The L visa offers several benefits to multinational companies. The L-1A visa facilitates an easier green card application through the EB-1C (Multinational Executive or Manager) category. Additionally, spouses and unmarried children under 21 years old can receive L-2 visas. L-2 visa holders (spouses) can work in the U.S., and children can continue their education, providing significant benefits for the entire family. However, there are important considerations during the application process. The stay period is limited to a maximum of 7 years for L-1A and 5 years for L-1B. Especially for L-1B visa holders, there may be challenges in proving "specialized knowledge," as USCIS evaluates whether the knowledge is specific to the company's proprietary processes or techniques.

The L visa is a powerful tool for entering the U.S. market and expanding business operations. Establishing a new office provides a stable foundation for business during the initial visa period, and subsequent extensions allow for long-term growth. However, the application process is complex, so it is crucial to systematically prepare documentation such as evidence of the company relationship, employment history, and business plans with the help of an expert.

The L visa plays a key role in helping multinational companies maintain competitiveness and expand in the U.S. market. By thoroughly preparing and seeking professional assistance during the application process, the chances of success can be significantly increased.
